- prepare them effectively for adjudication proceedings and

- how to explain what the process is, including its advantages and dangers
- how to manage clients' expectations
- how to collate evidence and prepare written submissions for an adjudication
- how to present oral evidence should a hearing be needed
- what to do with a decision once delivered
- how to get the decision enforced, and
- what to do if the decision is challenged

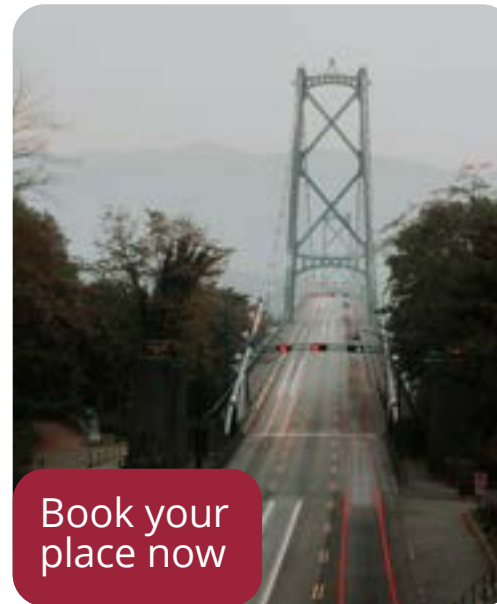
The program also provides a specific focus on conflicts of interest, ethics, and jurisdictional points that you may need to explain to or make on behalf of your clients.

This comprehensive 28 hour\* training program, builds on your Module 2 training - Advising and representing parties in adjudications.

This course is broken into units and is delivered over four to eight weeks to allow time for study and preparation between sessions.

It covers the remaining knowledge and competencies you need to practise as a construction adjudicator, with specific focus on :

- applicable common and statutory law,
- adjudication practice,
- managing the adjudication process and
- determination writing

\* this programme involves 28 hours contact teaching time – you will need at least the same amount of time for preparatory reading and study

### Who should attend?

This program is designed to train construction, engineering and related professionals in the law, practice and procedure of construction adjudication.

Construction adjudicators are usually drawn from contractors, quantity surveyors, architects, engineers, project managers and lawyers with a construction orientated practice
